ADMISSION NOTICE: Re-allocation of the working professional candidates
FOR DIRECT SECOND YEAR OF DIPLOMA COURSES IN ENGINEERING AND TECHNOLOGY
FOR ACADEMIC YEAR 2024-25

(for Separate Division of Direct Second Year of Diploma Courses for Working Professionals)

This Notice is being issued for Re-allocation of the working professional candidates provisionally admitted in Direct Second Year of Full Time Diploma in Engineering and Technology programs under Separate Division for Working Professionals in the Government, Government Aided, University Managed and Unaided private educational institutes for the Academic Year 2024-25 in the Maharashtra State.

Condition for Re-allocation of candidates for admission in separate division for working professionals: The institute can admit the Candidate for Institutional Quota and vacant seats after Two CAP Round till the precut-off date i.e. 06.09.2024 only. If the admissions to a course after pre-cut-off date are below $\frac{1}{3}$ rd of the approved intake then the Re-allocation of candidates from the courses having admissions less than $\frac{1}{3}$ rd of sanction intake shall be carried out by the Competent Authority.

<u>Important Instructions for candidates:</u>

- 1. For Working Professionals: Candidates desirous to take admission in separate division for Working professionals of Direct Second Year Diploma in Engineering and Technology shall read carefully the Rules published in clause C(4) "Allocation of Seats for Working Professionals (Supernumerary Division)" under Schedule –III of the Information Brochure.
- 2. Participation in reallocation process does not guarantee the reallocation or admission of the Candidate.
- 3. Working professional has to take admission to reallotted institute within stipulated time schedule specified by the Competent Authority.
- 4. Provisional Admission of the candidate shall be cancelled automatically if the Candidate
 - a. fails to submit and confirm the Preference Form for the Re-allocation process.
 - b. does not get a seat in the Re-allocation process as per eligibility criteria.
 - c. fails to report to the institutes as per Re-allocation process as per schedule
- 5. Courses in the Institutes having admissions below 1/3rd admissions after pre cut-off date has to refund full fees and original documents to the Candidate in case of cancellation of provisional admission / reallotment immediately within two days from the cancellation of admission/re-allotment.

Note:

- 1. Once the candidate confirms his/her Re-allocation Preference form online through his/her Login, Candidate will not be allowed to change/cancel the option/preference submitted under any circumstances.
- 2. The Re-allocation list displayed on website will show the provisional Re-allocation offered to the Candidates. No personal communication or allotment letters in this regard shall be issued to the Candidates.
- 3. A Candidate who has been Re-allocated shall download the "Provisional Seat Re-allocation Letter" from his/her Login.
- 4. At the time of reporting for Re-allocation admission to Institute, the candidate shall produce all the original documents in support of the claims made in the application. In the event the candidate fails to produce the documents in support of the claim, so made in the application, the Re-allocation allotment shall stand cancelled automatically. Candidates are advised to keep ready the required documents at the stage of self-verification of documents as per the notified schedule.
- 5. In later stage, if it is found that the seat allotted to the candidate is on the false claims made in the application by the candidate, then such Re-allocation allotment/admission taken in the allotted institute shall be cancelled.
- 6. Candidate shall produce the relevant & valid documents to substantiate the claim made in the application form. In case of non submission of the relevant documents, the candidate shall lose such claims made in the application and applications of such candidates shall be confirmed without considering such claims.
